

# "HAMLET" PLAYED AT THE COLUMBIA

Sothern Proves a Surprise in the Part and Julia Marlowe Is the Most Charming Ophelia—All Other Roles Well Acted.

SHAKESPEARE is not dead; he is not even dying. Quite the contrary, after being the presentation of "Hamlet" at the Columbia Theater last night, I venture to say that the outlook for the future of Avon has never been more promising or healthy in my time. It may not be in all respects the traditional Shakespeare, but it is all the more promising for that, for while Shakespeare is there as before, the whole spirit of the reading is modern. The ponderous methods of earlier days are gone. In fact, the naturalness of Booth and other great stars, whose example never seemed to affect the rest of the cast, is now being taught to the actors who play the lesser roles.

Charles Frohman has redeemed many of the less worthy works he has brought to the stage. He has brought to the stage a play which is a great deal more than a commercial venture. These two stars are imbued with the higher ideas of acting, and they are not only reviving the great plays which of late have had but haphazard production, but they are also reviving the Shakespearean art which offers in all respects a superior education to that which the older combinations did. It is noticeable that the reading of Shakespeare by the subordinate people in this company has been unusually good. For this the earnest work of both Julia Marlowe and Mr. Sothern are responsible. What the old actor learned, he learned by simply studying the others, who had learned before him in the same way. In this case it is very different. Miss Marlowe and Mr. Sothern are not only studying to go over the play, discussing the emphasis and accentuation and marking the lines for the best expression. Each actor gets his book of the play with every proper emphasis marked and he learns the speech in that way. This gives us a clear and distinct picture of the effective delivery. The profound interest which the two leaders take in their work therefore extends to everybody in the play, and so here is a genuine school of the legitimate drama, with twentieth century ideas.

This is the explanation of the fact that the presentation of "Hamlet" last night at the Columbia was not discussing the stars at all, the best all-around one I have ever witnessed. Every character had his place and his effect in the tragedy, as in the picture, and even Hamlet's ghost spoke like a man and not as a hollow-voiced supernatural figure from the regions of the imagination. I can imagine that when Mr. Sothern first appeared as Hamlet four years ago he was crude and not well equipped for the role. A man cannot play Lord Chumleys and romantic plays like "If I Were King" and then there the education for Hamlet. But four years of desultory playing have made Mr. Sothern a Hamlet of great present merit and of still greater future promise. New York rather denied him even this season. But then Charles Robertson has been hailed this year there as a wonderful "Hamlet," while last year he played the part without any such acknowledgment. Mr. Sothern will develop still further. You can see he will. He has already achieved wonders with the first two acts. The very evening last night seemed to be something of a surprise to the audience, who had not expected such a performance. They had formed their expectations, doubtless, on "The Proud Prince" and other pieces they had seen him in.

There was before us a young Hamlet, a Hamlet who, more than all others, conveyed the idea of the appropriate combination of maturity and youth. He looked young enough, while in voice, in firmness, decision and intonation he convinced us of mental maturity. He was melancholy, more melancholy than most Hamlets; yet his sincerity and the genuineness of his feeling could not be denied. I felt that the greater Hamlets do that part of the play very much worse. There was something of comradeship really between him and Horatio; there was a touch of youth in both, which drew something of new sympathy, although the distinction between them was thoroughly preserved.

The ghost scene was so well played it would have been acceptable in the great Hamlets, and indeed, Mr. Sothern was very convincing all through it. He was much more nerve-shaken than many we have seen, and his nervousness did not leave him, as it has done with others, as soon as the ghost has gone.

Fresh, unconventional, copying nobody in particular, he gave to Hamlet his own personality and his own temperament. His soliloquy was naturally delivered, and the scene with Ophelia was not faded. Ophelia woke something of sentiment in him, which appeared reasonable and appropriate. Here, however, in the latter part he became more turgid and for a little the character rather got away from him. The talk with the players was not as good either, but the only fault one could find with his play scene was that it hardly seemed dignified in him to seize the King as he did when he left the room. The admirably done was his dialogue with Rosencrantz and Guildenstern. But after that he began to grow turgid again, and the scene with his mother was too fierce; there was too much tumultuousness, and the business was exaggerated to confusion. In the speech, when he watches the King praying, he lost himself a little, too.

Something is to be said of the conception of sustained nervous excitement from the play scene on through those other two, but Mr. Sothern does not control it enough. Discreetly used, as he will by and by be able to do, it should add strength and interest to the performance. The grave-digger act is not difficult, and the later acts

develop little more of Hamlet's character.

Mr. Sothern's Hamlet has a basis of poetry; he does much beautiful reading, but one of his imperfections is that he does not yet attain the poetic to the more prosaic tone necessary in various parts of the play. His sentiment comes occasionally from his throat, and it sounds like affectation in such places as where he uses it toward his mother. No one knows better than Mr. Sothern that there are a thousand subtleties of meaning in Hamlet, nobody knows better that he is but beginning to study the role; but he has in him to be a Hamlet of high rank and to play it is an ambition worthy of his every effort. We cannot have enough Hamlets.

To speak of the Ophelia of Julia Marlowe is to find detail impossible. Ophelia is a character in which grace and feeling dictate tone, movement, gesture. Miss Marlowe puts forth her own personal charm; she lets that carry much, and she needs to put out no other effort. Her attention cannot be misdirected, and she is without effort or demonstration. Her very first appearance seems to add the poetry, the sentiment, the light to the play. Modest, simple, without a pose, she draws us; she has little to say till the mad scene, but somehow she is a light that has gone out of Hamlet's life, and that she seems almost to know herself. Her feeling for Hamlet is sincere; it is pure and modest, and she is almost the only Ophelia I ever saw who really suffered with the man. Only pity in her face, and in her tone, pity and some of her own suffering, make her wonderfully sympathetic. This Ophelia might have gone mad; I hardly remember another who would. And her pity for Hamlet, we feel for her when she plays the mad scene. It is not vacancy of expression; it is a sense of suffering and a suggestion of mental pain, that makes her mad speeches so much more sad and pitiful. And indeed, "Sweetest to the sweet" strikes a chord that everybody feels.

The ensemble, as I have said, calls for high commendation.

Hamlet will be given twice today. "Romeo and Juliet" comes on Monday. PETER ROBERTSON.

## JUDGE COOK ALTERS FORM OF COURT ORDER.

Attorneys Lloyd and Hegerty Win Their Point in Fair Case Litigation.

An important case was won in Judge Cook's court Thursday afternoon. Reuben H. Lloyd of the firm of Lloyd & Wood, and Charles Hegerty of Knight & Hegerty, attorneys for the defendant, won their case against the plaintiff, when their application to have struck out certain portions of an order secured by Joseph C. Porter, attorney for the plaintiff, was granted by the court. The order had been allowed to stand, it would have meant that the attorneys for the defendant could not have been able to collect any fees for services they might render in the future, since the order had been made by the court. Mr. Porter had agreed with Hegerty and Lloyd that the sum of \$100,000 should be paid to the plaintiff, present and future. On April 25th Judge Cook signed an order, on the plaintiff's application, setting aside the order, and the defendant was rendered "and to be rendered." He explained yesterday that the time he affixed his signature he had not read the order carefully, and the words "to be rendered," which Hegerty and Lloyd wanted stricken out, had escaped his notice.

## DELAY IN TRIAL MAY POSTPONE WEDDING.

The glumest-looking man in Judge Carroll Cook's courtroom yesterday morning, when the postponement of the McCarthy murder trial was ordered because of the continued illness of Juror William Raubinger, was Assistant District Attorney Porter, who has been conducting the prosecution. This will occur in July. Representatives of the Sutter Baths, who are the Fire Commissioners yesterday that a new company, established in the neighborhood of Cliff street in place of the outgoing engine corps. They have settled the matter by purchasing to station a company on Cliff street if the agents of the Sutter Baths will agree to add the necessary sum to the budget.
