Henry Ach of counsel for Eppinger & Co. was seen last night with reference to the situation, and asked his opinion concerning matters likely to develop in the course of proceedings to deviate the course of proceedings to-day in the District Court.

#### ATTORNEY MAKES STATEMENT.

"The liabilities of the firm," said Mr. Ach, "are \$1,250,000, and the known assets \$700,000. The debtors claim that sets \$700,000. The debtors claim that there is a surplus of \$100,000 in excess of the value of the securities on the \$350,000 claim of the London, Paris and American Bank. That reduces the liabilities to \$900,000, and the known assets consist of this \$100,000 surplus, besides \$125,000 worst. worth of grain in various country ware-houses; their interest in the Northwest Trading Company, worth \$40,000; real estate in San Luis Obispo country which cost \$50,000, but which has been ap-praised among the assets at \$40,000, and outside assets, including real property and warehouses at Dinuba, Lovell and Visalia, worth about \$50,000, together with Crockett warehouse property val-ued at \$75,000, and miscellaneous assets, the whole aggregating at least \$475,000. with its calendar now," said the Chief Justice yesterday, "that I would not feel justified in undertaking the work of umpire in this controversy. I have not been approached by either side in the matter and the only information I have received as to the suggestion of my name is from the reports in the newspapers. I feel highly honored that I should have been nominated for such an important office. I believe that great good is accomplished by courts of arbitration in alleviating friction between labor and capital, and that conference between honest and fair-minded men of the con tending factions is the proper method of adjustment of differences. Had I the time to devote to it, I would gladly give were I requested to serve as umpire. But under the circumstances it would be impossible, for my first duty is to the State of California, and there is now more litigation pending before the Supreme Court than the Justices can attend to."
